**Skin contact**

artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. Get medical attention immediately.

Remove contaminated clothing and shoes. Immediately flush skin with plenty of water. Get prompt medical attention. Wash contaminated clothing before reuse.

**Ingestion**

Immediately flush eyes with plenty of water for at least 20 minutes, occasionally lifting the upper and lower eyelids. Check and remove contact lenses. Continue to rinse for at least 10 minutes. Get medical attention immediately.

**Most Important symptoms /effects, acute and delayed**

Rinse mouth thoroughly with water. DO NOT induce vomiting. If victim is fully conscious, give a cupful of water. Never give anything by mouth to an unconscious person. If vomiting occurs, keep head lower than the hips to help prevent aspiration. Call a physician or poison control center immediately.
